## **MINUTES**

- **1. Those Present:** Cllrs Smith, Aylmer, James and Clatworthy. Cllr Baker Chaired the meeting, Cllr Perfect-Porter acted as Interim Clerk. Five members of the public attended.
- 2. Election of Officers Agreed to defer to the next meeting in the Chairs absence.
- 3. Apologies for Absence and Declarations of Interest and Dispensations: Cllr Hayne sent his apologies.
- 4. Statements by County Councillors: No update received.
- 5. Minutes of the meetings held on 10<sup>th</sup> April 2024: These were accepted as a true record and agreed unanimously by the Council.
